2. **Terms and Conditions :**

- (a) The vehicle will be disposed of on "AS IS WHERE IS BASIS" and there is no guarantee of its worthyness or serviceability.
- (b) Every bidder who wants to bid auction shall deposit an amount of Rs. 5000/- as security deposit and the successful bidder have to deposit the full bid amount including GST immediately and take delivery of the vehicle on the same day from the premises of Armed Forces Tribunal, Principal Bench, New Delhi.
- (c) The inspection of the vehicle would be open, half an hour before the public auction time.
- (d) During the auction process, acceptance or rejection of a bid should be announced immediately on the stroke of the hammer. If a bid is accepted, sale proceeds/full bid amount will immediately be taken on the spot from the successful bidder either in cash or in the form of DD/Pay Order drawn in favour of Principal Registrar, Armed Forces Tribunal (Principal Bench), New Delhi.



- (e) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Aadhar Card/Voter Identity Card/Passport in case of individual and Registration Certificate in case of firms etc.
- (f) If it is found that the amount quoted by the successful bidder is less than the Reserve price fixed by the Competent Authority or the total number of bidders are less than three the bid may be treated as cancelled.
- (g) The Earnest Money of the successful bidder will be released only after the deposit of full sale proceeds. The Earnest Money will be treated as forfeited if he fails to honour the bid.
- (h) The successful bidder has to remove the vehicles at his own cost on payment of full bid amount on the same day, failing which resale of the vehicle will be undertaken at the risk and cost of the defaulter.
- (i) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at their own cost expeditiously. The Tribunal will not be responsible for any lapse on his part in this regard.
- (j) The Competent Authority reserves the right to accept or reject bid auction without assigning any reason.
- (k) All taxes/levies etc. will be borne by the buyer over and above the bid price.
- (l) Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.
- (m) The highest bid once accepted is not transferable to anyone. In case the bidder is a company, the name of the company should be indicated as the bidder. In such case the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company.
- (n) The unsuccessful bidders who have deposited Security Money shall be entitled to have the same refunded without any interest immediately after the sale becomes absolute.
- (o) Officers and Staff of the Armed Forces Tribunal are not permitted to participate in the bidding process.
