A case may also be sent by registered post or by courier with acknowledgement due addressed to Registrar of the Bench concerned on prescribed format(Form-I) of Appendix-'A', as provided in the AFT Act, 2007/Rules framed there under, particularly Rule 4 of AFT (Procedure) Rules 2008 (photocopy attached).

**SUB SEEKING INFORMATION UNDER RIGHT TO INFORMATION ACT 2005**

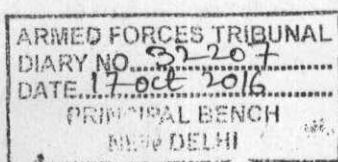
Sir,

My late husband Sep Bachi Ram enrolled in Kumaon Regiment Ex Sep 3428887 date of enrolment 1 March 1945 date of discharge 01 March 1960 and then enrolled in Bihar Military Police after completing his service from both the department he was retired from service and granted pension from Bihar Military Police Pension Payment Order No Bihar /326.As per that time pension laws only one pension was allowed.

2 After the dead of my husband on 29 March 1997 I was granted family pension from Bihar Military Police in my Bank account SB no 16800100000699 A/c Holder Mrs Bhagirathi Devi wife of Late Bachi Ram from Bank of Baroda branch Chorgalia Distt Nanital Uttrakhand.

3 In year 2014 my PDA (Bank of Baroda Branch Chorgalia Distt Nanital Uttrakhand) had stopped payment of family pension to me without giving me valid reason for the same. After my repeated request and applications Bank of Baroda (PDA) letter no ROH:RTI:PIO:29/101 dated 21-03-2016 as par Para 3 of the above letter I was in receipt of Defence Pension but I was entitled for Bihar Military Police Pension Payment Order No Bihar /326.Hence PDA had stopped my family pension and there is recovery of amount paid to me as family pension.

4 Being in my old age and family pension being only source of income to purchase my medicines and food from last two and half years my survival has become difficult. I am not aware about who is responsible for this blunder that I was in receipt of Defense Pension but I was entitled for Bihar Military Police Pension Payment but because of this mistake I innocents' old age widow pensioner is deprived form legal pension from more than two years I am bound to beg for my bread and butter and deprived from medical aid as I don't have money, being in my old age I don't know till what time I will survive without proper food and medicines.

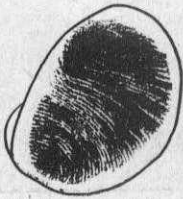
