One Staff Car (Maruti Suzuki SX4 (White) (petrol) of Armed Forces Tribunal Regional Bench, Kochi will be auctioned in public in the premises of Armed Forces Tribunal on **29-08-2018 at 11.00 A.M.**

The intending bidders can participate in the auction by remitting Rs 7250/- (Rupees seven thousand two hundred fifty only) as Earnest Money deposit. EMD should be remitted before 10.30 a.m on 29-08-2018, the day of auction, in the Account Section of this Tribunal and the receipt of the same shall be produced at the time of auction.

The intending bidders should satisfy themselves about the condition of the vehicle put up for auction on any working day with the prior permission of Registrar, Armed Forces Tribunal, Regional Bench, Kochi and no complaints will be entertained after the auction.

The intending bidders can have the choice to quote the bid amount in a sealed cover and hand it over to the Auctioning Officer prior to the commencement of the auction. The sealed covers containing quotations will be opened before finalizing the auction.

The auction shall be fixed temporarily in favour of the person who has offered the highest bid in the auction or in the sealed cover, whichever is higher and the bidder shall deposit the amount in full within 7 days, less the Earnest Money Deposit.

The EMD deposited by the bidders except the persons in whose favour the bid has confirmed shall be returned immediately after the auction.

If the person in whose favour the auction has been confirmed fails to deposit the bid amount within the time period, the earnest money deposited by him shall be forfeited and the person in whose favour the auction has been fixed shall be held responsible for loss if any, caused to the Armed Forces Tribunal, Regional Bench, Kochi on conducting the re-auction.

Vehicle sold at the auction shall on no account be retained in the office for long. In the event of failure to take delivery of the vehicle within 15 days from the date of auction, the vehicle may either be arranged to be re-auctioned or released to the original bidder himself on realization of retaining fee. In the event of re-auction, the amount remitted by the successful bidder at the previous auction will be forfeited.

The officer conducting the auction shall have the authority to annul or invalidate the auction and also postpone the auction without assigning any reason.

Since the vehicle is with the Defence Registration, it is the responsibility of the successful bidder to register the vehicle with respective Regional Transport Authority.

The officer conducting the auction shall have the authority to take all sorts of decision in matters pertaining to the auction. The decisions thus rendered shall be final.
