### Subject:- Selection of Administrative Members of the Armed Forces Tribunal

Applications are invited from eligible serving or medically fit retired officers of Army, Navy, Air Force as per the eligibility criteria stated below for filling up of one (1) anticipated vacancy of Administrative Member in the Armed Forces Tribunal.

2. Section 6(3) of Armed Forces Tribunal Act, 2007 (55 of 2007) amended vide SRO 18 (E) dated 21.07.2008 provides that

"A person shall not be qualified for appointment as Administrative Member, unless -

- (a) he has held or has been holding the rank of Major General or above for a total period of at least three years in the Army or equivalent rank in the Navy, or the Air Force; or
- (b) he has served for not less than one year as Judge Advocate General in the Army or the Navy or the Air Force, and is not below the rank of Major General, Commodore and Air Commodore respectively.
- 3. In terms of the Supreme Court order dated 20.03.2018 in WP (C) 279/2017, Kudrat Sandhu vs UoI and Others, term of office of the Member of Armed Forces Tribunal is for five (5) years or the maximum age for holding office by the Member i.e. sixty-five years as provided by section 8 of Armed Forces Tribunal Act, 2007 (55 of 2007).
- 4. Salary, allowances, other terms and conditions of the Members of the AFT, shall be governed by the provisions of the Armed Forces Tribunal Act, 2007 (55 of 2007).
- 5. The selected persons are liable to be posted to anywhere in India having a Bench of the Armed Forces Tribunal and the appointment shall carry an All India transfer liability.
- 6. Eligible officers may forward their applications along with their bio-data in the prescribed format (copy enclosed) for the post of Administrative Member in the Armed Forces Tribunal, in hard copy as well as via email in pdf format to usaft-mod@nic.in.
- 7. The information and material pertaining to the following categories are required to be enclosed along with the hard copy of application/bio-data in the prescribed format for the post of Administrative Member in the Armed Forces Tribunal:-

- (i) Army, Navy & Air Force: Any decision/order given by the applicant during his service in disciplinary matters and if it can be provided.
- 8. The applications along with enclosures in the prescribed format may be sent as mentioned in para 6 and para 7 above to Ministry of Defence, latest by 17th August, 2018 at the following address. It is reiterated that the material mentioned in para 7(i) above need not be sent via email.
