**CIRCULAR**

1. Applications are invited for filling up of the following posts in the Armed Forces Tribunal, Regional Bench, Chandigarh on deputation/re-employment on contract basis for a period of one year from the candidates who fulfill following eligibility conditions:-

3. The pay and allowances and other terms and conditions of officer/official selected on deputation will be governed in accordance with DOP&T O.M No 6/8/2009-Estt.(Pay-II) dated 17.06.2010, as amended from time to time.
4. **Age Limit.**
- (a) **Deputation.** The maximum age limit for appointment on deputation shall not exceeding 56 years as on the closing date for receipt of applications.
- (b) **Re-employment on contract basis.** The maximum age limit for the re-employment on contract basis is 64 years. The gross pension will be reduced from the pay fixed, in case of retirees after the age of 55 years.
5. **Please note that:-**
- (a) Applications received after the last date will not be entertained and no correspondence in this regard will be entertained.
- (b) Applications for Adhoc deputation will have to be routed through their parent department.
- (c) **Applications for one year on re-employment on contract basis only** from Ex-servicemen, retired Central/State Govt. and Courts staff will be considered.
6. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall not ordinarily exceed three years.

7. The competent authority is empowered to relax any of the eligibility conditions.
8. The application(s) in the prescribed Proforma (Annexure I) from eligible officers/officials who can be spared for deputation in the event of their selection may be forwarded to the Registrar, Armed Forces Tribunal, Regional Bench, Chandigarh, near Tank TCP, Chandimandir, Haryana-134107 **latest by 20<sup>th</sup> September, 2017**, alongwith photocopies of the annual confidential reports for the last five years and vigilance clearance certificate.
9. The applicant(s) for re-employment on contract basis may send their applications directly **by the aforesaid date** alongwith all the relevant documents duly attested in support of his/her date of birth, educational qualifications, retirement/discharge book, LPC, PPO and all other documents showing his/her fulfilling of eligibility criteria viz, requisite service/experience for the post applied for.
