**CIRCULAR**

1. Applications are invited for filling up the following post in the Armed Forces Tribunal, Regional Bench, Chennai on deputation initially for a period of one year and extendable as per DoP&T orders / re-employment on contract basis for a period of one year from the candidates who fulfill the following eligibility conditions :-

Deputation Basis :-</b> (i) Officials under the Central Government or State Government or High Court or District Court holding analogous post or Subordinate Accounts Service Accountants, Junior Accounts Officers in the various Accounts Organizations of Central/ State Governments.  OR (ii) Upper Divisional Clerks of Central Govt. or State Govt. or District Courts with ten years service in the grade who have undergone cash and Accounts Training in the Institute of Secretariat Training and Management or equivalent or possess three years experience of cash accounts and Budget works.  <b>2. Re-employment on Contract Basis :</b> Persons retired from analogous post or posts from Central Government or State Government or High Court/ District Courts as mentioned above.

2. The Pay & allowances and other terms & conditions of the officer selected on deputation will be governed in accordance with DOP&T O.M. No 6/8/2009-Estt.(Pay-II) dated 17.06.2010, as amended from time to time.

3. **Age Limit.**

- (a) **Deputation.** The maximum age limit for appointment on deputation shall not be exceeding 56 years as on the closing date of receipt of application.
- (b) **Re-employment on contract basis.** The maximum age limit for the re-employment on contract basis is 64 years.

4. Please note that :-

- (a) Applications received after the last date will not be entertained.
- (b) Application for Deputation will have to be routed through their parent departments.
- (c) **Applications for one year on re-employment on contract basis** only from retired Central/ State Government/ Court Staff/ Tribunals/ Statutory bodies and Autonomous bodies will be considered.

5. Number of vacancies may vary and filling up of the post(s) is at the discretion of the Competent Authority.

6. (a) The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion channel

(b) The period of deputation including the period of deputation in ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.

7. The application(s) in the prescribed proforma (Annexure-I) from eligible officers who can be spared for deputation in the event of their selection may be forwarded to the Registrar, Armed Forces Tribunal, Regional Bench Chennai, 1A, Old MH Complex, Rudhra Road, St.Thomas Mount Chennai-600016 by **02<sup>nd</sup> Mar 2018** alongwith photo copies of the annual confidential reports for the last five years and vigilance clearance certificate.
