**CIRCULAR**

1. Applications are invited for filling up the following post in the Armed Forces Tribunal, Regional Bench, Chennai on deputation basis/ re-employment on contract basis for a period of one year or till the vacancy is filled up as per Recruitment Rules, whichever is earlier, from suitable candidates who fulfill the eligibility conditions as mentioned below :-

In case of deputation :</b> (a) Persons holding analogous posts of staff car drivers in Ministries or Departments of the Central Government or State Government or Supreme Court or High Courts and Subordinate Courts on regular basis.  Persons must possess the qualification prescribed as under :-  <b>Essential :</b> (i) 10 <sup>th</sup> Standard pass from a recognized Board. (ii) Experience of driving a motorcar for at least three years. (iii) Possession of a valid driving licence for motorcars. (iv) Knowledge of motor mechanism (should be able to attend to minor-defects in vehicle). <b>2. In case of re-employment :</b> With qualifications and experience similar to deputationists.

2. The Pay of the Staff Car Driver selected on deputation will be governed in accordance with DOP&T O.M. No 6/8/2009-Estt.(Pay-II) dated 17.06.2010, as amended from time to time.

3. **Age Limit.**

(a) **Deputation.** The maximum age limit for appointment on deputation shall not be exceeding 56 years as on the closing date of receipt of application.

(b) **Re-employment on contract basis.** The maximum age limit for the re-employment on contract basis is 64 years. The gross pension will be reduced from the pay fixed, in case of retirees after the age of 55 years.

4. Please note that :-
- (a) Applications received after the last date will not be entertained.
- (b) Application for deputation basis will have to be routed through their parent departments.
- (c) **Applications for one year on re-employment on contract basis** only from retired Central / State Governments/ Court Staff/ Tribunals/ Statutory bodies and Autonomous bodies will be considered.
5. The competent authority is empowered to relax any of the eligibility conditions.
6. (a) The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion channel
- (b) The period of deputation including the period of deputation in ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.
7. The application(s) in the prescribed proforma (Annexure-I) from eligible individual who can be spared for deputation in the event of their selection may be forwarded to the Registrar, Armed Forces Tribunal, Regional Bench Chennai, 1A, Old MH Complex, Rudhra Road, St.Thomas Mount Chennai-600016 by **17<sup>th</sup> Apr 2017** alongwith photo copies of the annual confidential reports for the last five years and vigilance clearance certificate.
8.
