CIRCULAR

1. Applications are invited for filling up the following post in the Armed Forces Tribunal, Regional Bench, Chennai on deputation initially for a period of one year and extendable as per DoP&T orders / re-employment on contract basis for a period of one year from the candidates who fulfill the following eligibility conditions :-

2. The Pay & allowances and other terms & conditions of the individual selected on deputation will be governed in accordance with DOP&T O.M. No 6/8/2009-Estt.(Pay-II) dated 17.06.2010, as amended from time to time.

3. **Age Limit.**

(a) **Deputation.** The maximum age limit for appointment on deputation shall not be exceeding 56 years as on the closing date of receipt of application.

(b) **Re-employment on contract basis.** The maximum age limit for the re-employment on contract basis is 64 years.

4. Please note that :-

(a) Applications received after the last date will not be entertained.

(b) Applications for deputation basis will have to be routed through their parent departments.

(c) Applications for one year on re-employment on contract basis, only from retired Central/ State Government/ Court Staff/ Tribunals/ Ex-servicemen/Statutory and Autonomous Bodies, will be considered.

5. Number of vacancies may vary and filling up of the post(s) is at the discretion of the Competent Authority.

6. The period of deputation including the period of deputation in ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of application.

7.
