In case of Deputation</b> (Including Short Term Contract) :-  Officers of the Central Govt or State Govt or Supreme Court or High Courts or Distt Courts or Statutory/Autonomous bodies having pensionary benefits:  (a) (i) holding analogous post on regular basis in the parent cadre or Department; <b>or</b>  (ii) with five years regular service in the parent cadre or Department in post in Level-10 of Pay Matrix (PB-3 Rs.15600-39100+GP Rs.5400 -pre revised), <b>or</b>  (iii) with six years regular service in the parent cadre or Department in post in Level-8 of Pay Matrix (PB-2, Rs. 9300-34800+GP Rs.4800 (pre revised); <b>or</b>  (iv) with seven years regular service in the parent cadre or Department in post in Level-7 of Pay Matrix (PB-2 Rs.9300-34800+GPRs.4600 pre revised); <b>and</b>  (b) having five years of experience in personnel and Administrative or Judicial work. <b>Desirable</b> : Possessing a degree in law from a recognized University.  <b>2. In case of re-employment :</b> With qualification and experience similar to deputationists.

2. The Pay & Allowances and other terms and conditions of the official selected on deputation will be governed in accordance with DOP&T O.M. No 6/8/2009-Estt.(Pay-II) dated 17.06.2010 and O.M even number dated 22 Apr 2016, and O.M. No 3/3/2016-Esttt (Pay-II) dated 01.05.2017as amended from time to time.
3. **Age Limit.**
- (a) **Deputation.** The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of application.
- (b) **Re-employment on contract basis.** The maximum age limit for the re-employment on contract basis is 64 years.
4. **Please note that:-**
- (a) Applications received after the last date will not be entertained.
- (b) Application for deputation will have to be routed through their parent departments, duly recommended by the competent authority.
- (c) **Applications for one year on re-employment on contract basis** only from retired Central/State Governments/Court Staff/Tribunals will be considered.
5. The competent authority is empowered to relax any of the eligibility conditions.
6. (a) The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion.
- (b) The period of deputation including period of deputation (Including Short Term Contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall not ordinarily exceed three years.
