

CIRCULAR

1. Applications are invited from Serving/Retired employees of Central Government or State Government or Supreme Court or High Courts or District Courts or Statutory/Autonomous bodies for filling up the following posts in Armed Forces Tribunal, Regional Bench, Jabalpur (MP) on deputation (Including short Term Contract)/ Absorption and/or re-employment on contract basis for a period of one year from eligible/suitable candidates who fulfill conditions as shown below for the following post:-

Similarly a deputationist in the Armed Forces Tribunal shall not be eligible for promotion.</p> <p>Note II. The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other origination or Department of the Central Govt shall ordinarily not exceed three years. The maximum age limit for appointment by deputation or absorption shall not exceed 56 years as on the closing date of receipt of application.</p> <p>(b) <u>In case of Re-Employment.</u> With qualifications and experience similar to Deputationist.</p>

2. The vacancies shown against posts in this circular are tentative which may decrease.
3. The pay & Allowances and other terms and conditions of the officer/official selected on deputation will be governed in accordance with DOP&T O.M. No. 6/8/2009-Estt. (Pay-II) dated 17.06.2010, O.M. even number dated 22 Apr, 2016, O.M. No. 3/3/2016-Estt. (Pay II) dated 01.05.2017 and F. No. 2/6/2018-Estt. (Pay II) dated 18.05.2018.
4. **Age Limit:**
- (a) **Deputation.** The maximum age limit for appointment on deputation shall be 56 years as on the closing date for receipt of applications, i.e. **20th December, 2018.**
- (b) **Reemployment on contract basis.** The maximum age limit for the re-employment on contract basis is 64 years. The gross pension will be deducted from the amount of pay fixed, where applicable.
5. The period of deputation, including period of deputation on ex-cadre posts held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years.
6. **General Information:-**
- (a) Legible Xerox copies of all the educational and other certificates duly attested by some Gazetted officer are required to be attached along with application form.
- (b) Application for deputation will have to be routed through the parent department duly forwarded by the competent authority.
- (c) Persons applying for re-employment on Contract basis are required to attach copy of PPO Form along with copies of educational and other certificates.
- (d) Applications received after last date shall not be entertained.
