

Desirable: Possessing a Degree in law from a recognized University. In case of re-employment: With qualifications and experience similar to deputationists.

- 2. The pay and allowances and other terms and conditions of the officer/official selected on deputation will be governed in accordance with the DoP&T O.M No. 6/8/2009-Estt (Pay-II) dated 17-06-2010 as amended from time to time and O.M 3/3/2016-Estt (Pay II) dated 01-05-2017.
- 3. Age Limit.
 - (a) <u>Deputation</u>. The maximum age limit for appointment on deputation shall not exceed 56 years as on the closing date of receipt of applications.
 - (b) <u>Re-employment</u>. The maximum age limit for re-employment on contract basis is 64 years.
- 4. Please note that :-
 - (a) Applications for deputation will have to be routed through their parent departments.
 - (b) Applications for one year on re-employment on contract basis only from retired Central/State Govt/Court Staff/Tribunals/Statutory bodies and Autonomous bodies will be considered
- 5. Number of vacancies may vary and filling up of the post(s) is at the discretion of the Competent Authority.
- 6. The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion channel.

- 7. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall not ordinarily exceed three years.
- 8. The applications in the prescribed proforma enclosed, (Annexure-I) from eligible officers/officials who can be spared for deputation in the event of their selection may be forwarded by the Departments to the Registrar, Armed Forces Tribunal, Regional Bench, Bristow House, K.J.Herschell Road, Kochi-682001, latest by 13th December, 2018 along with photostat copies of the annual confidential reports for the last five years and vigilance clearance certificate.
- 9. The applicant(s) for re-employment on contract basis may send their applications (Annexure-II) directly to the Registrar, Armed Forces Tribunal, Regional Bench, Bristow House, K.J.Herschell Road, Kochi-682001 by the aforesaid date alongwith photostat copies of all the relevant documents like PPO, Date of Birth Certificate, education certificates, experience certificates, discharge book etc. where applicable.


