CIRCULAR

Applications are invited for appointment the post of Registrar in the Armed Forces Tribunal, Regional Bench, Lucknow on deputation basis initially for a period of one year extendable upto 03 years/on re-employment on contract basis for a period of one year from suitable candidates who fulfill the following eligibility conditions:-

(b) holding degree in law from a recognized University with five years regular service. <u>For re-employment on contract basis:</u> Officers with similar qualifications and eligibility as for deputation.

2. The pay of the officer selected on deputation basis will be governed by DoP&T O.M. No. 6/8/2009-Estt(Pay-II) dated 17.06.2010, as amended from time to time.
3. The maximum age limit for appointment on deputation shall be 56 years as on the closing date for receipt of applications.
4. The maximum age limit for the re-employment on contract basis is 64 years. The gross pension will be reduced from the pay fixed.


5. The departmental officers in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the Armed Forces Tribunal shall not be eligible for consideration for appointment by promotion channel.

6. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall not ordinarily exceed three three years.

7. The application (s) in the prescribed Proforma (Annexure I) of the eligible officer(s) who can be spared in the event of their selection may be forwarded to the Principal Registrar, Armed Forces Tribunal, Principal Bench, by the Departments latest by **21 Jul 2017 (Friday)** along with photo copies of the Annual Confidential Reports for the last five years of the candidates alongwith Vigilance Clearance Certificate.

8. The applicant (s) interested in applying, for the post of Registrar on re-employment on contract/deputation basis may send their application (s) directly by the aforesaid date along with all the relevant documents like PPO, Date of Birth Certificate, L.L.B. Certificate, Experience Certificate etc.

9. The applications without supporting documents, photograph, unsigned and incomplete applications, in any manner, shall be summarily rejected.
