CIRCULAR

Applications are invited from the retired officers/officials for engagement as Consultant for doing Stenographic work in the Armed Forces Tribunal, Principal Bench, New Delhi having a speed in English Shorthand @100 wpm for a period of six months or till the post of Tribunal Master (Stenographer Grade I) is filled as per Recruitment Rules, whichever is earlier on a consolidated monthly remuneration of Rs. 40,000/- per month without any allowances/facilities.

2. The maximum age of engagement of Consultants will be 65 years. However, the same will be relaxed in case of deserving candidates. Preference will be given to the candidates having judicial background. The terms and conditions of the contractual assignment shall be as under:-

- (i) Engagement on contractual basis will be subject to satisfactory performance and it can be terminated by the Tribunal without assigning any reason whatsoever at any time. However, the candidates engaged on contractual assignment will have the option to give up their assignment by giving one month's advance written notice.
- (ii) The contractual assignment shall not confer any right or claim to any regularization or continuance in service.
- (iii) The candidates engaged on contractual assignment shall not be entitled for HRA, DA, residential accommodation or any other allowance.
- (iv) The candidates engaged on contractual assignment will be entitled to one day paid leave for each completed month. In case of leave in excess of one day per month, deduction on pro-rata basis would be made from the lump sum contractual amount payable to him.
- (v) Their working days and working hours shall be same as are applicable to other serving officers and employees of the Tribunal. However, depending upon

the need and requirement of the Member to whom they are attached, they will be liable to work beyond office hours and even on Saturdays, Sundays and other holidays without payment of any extra remuneration.

3. The interested/eligible retired officer/officials who are willing to serve in the Armed Forces Tribunal may submit their applications as per format annexed within 10 days from the date of publication of the notice to the following address:

4. Applications received after due date will not be considered and summarily rejected.
5. The candidates who are declared qualified in the skill test in English Shorthand will be called for interview. No TA/DA will be admissible for appearing in the skill test or interview.
6. The candidates who are called for interview will be required to submit self-attested copies of certificate and testimonials in support of date of birth, education qualifications, experience, etc. and show the originals thereof for verification.
