In the morning when we had started hearing arguments, Mr. S.P. Sehrawat, Advocate for the bank appeared and referred to one **Annexure R-6**. However, the same was not in the file. The matter was passed over for

the counsel to place on record the document. When the matter was taken up again although bunch of documents including Annexure R-6 has been handed over to us by court master but Mr. S.P. Sehrawat, Advocate is not responding. He has handed over his own bunch carrying Annexure R-6. Counsel for the applicant and the counsel for Union of India submits that they have not received this document. In fact, counsel for UOI states that he has not received the reply filed by the bank.

It is very shocking that when the matter has now been taken up, again Mr. S.P. Sehrawat, Advocate is not responding. Record reveals that he is hardly appearing in the matter and every time we have to issue notice to the bank. Let the bank be intimated about the conduct of the advocate and we make it clear that henceforth, we will not be issuing notice either to the bank or to the counsel because when Mr. S.P. Sehrawat was not appearing for number of hearing and the Contempt proceedings were initiated against the Bank Manager, we had issued separate notice to the Bank Manager which was duly served upon him, yet he has failed to appear.

In order to avoid further delay in the matter, we would request the Registry to supply copy of Annexure R-6 to counsel for the applicant as well as Respondents (UOI). Copy of Annexure R-6 be also sent to Learned Administrative Member.

Counsel for UOI states that in case of need, he will file reply to Annexure R-6. He is permitted to do so.
