MA stands disposed of.

OA 2074/2018

Invoking the jurisdiction of this Tribunal under Section 14 of the Armed Forces Tribunal Act, 2007 the applicant has filed this application and the reliefs claimed in para 8 read as under:

- (a) *Direct respondents to treat the disability Primary Hypertension with Hypertensive Heart Disease of the applicant as attributable to/aggravated by military service and grant disability element of pension from the*

*date of retirement of the applicant along with benefit of broad banding.*

*(b) Direct respondents to pay the due arrears of disability element of pension with interest @ 12% p.a. from the date of retirement with all the consequential benefits.*

*(c) Any other relief which the Hon'ble Tribunal may deem fit and proper in the fact and circumstances of the case.*

2. The applicant was enrolled in the Indian Army on 04.12.2001 and discharged from Service on 31.12.2017. The applicant submits that for the purpose of Primary Hypertension, the disability has been assessed @ 30% as is evident from the medical records. The composite disability for the ailment has also been assessed at 30%.

3. Keeping in view the consistent stand taken by this Tribunal based on the law laid down by the Hon'ble Supreme Court in the case of *Dharamvir Singh Vs. Union of India and others* (2013) 7 SCC 316 that Primary Hypertension may arise even in a peace area due to stress and strain of service, we see no reason not to allow the prayer of the applicant with regard to the disability of Primary Hypertension, which has been assessed by the competent Medical Board @ 30%.

4. Accordingly, we allow this application and direct the respondents to grant disability element of pension to the applicant @ 30% for life which be rounded off to 50% for life from the date of retirement, i.e., 31.12.2017 in terms of the judicial pronouncement of the Hon'ble Supreme Court in the case of *Union*

*of India Vs. Ram Avtar (Civil Appeal No. 418/2012)* decided on 10.12.2014.

5. Accordingly, the respondents are directed to:
  - (i) calculate, sanction and issue necessary PPO to the applicant within four months from the date of receipt of copy of this order, failing which, the applicant shall be entitled to interest @ 6% per annum till the date of payment.
6. No order as to costs.
7. Pending MA (s), if any, stands closed.
