Vide order passed on 9<sup>th</sup> May, 2023 in OA 1088/2019 this Tribunal had directed the respondents to conduct the Re-Survey Medical Board as directed as per Para 9 and take action within two months. Inter alia contending that Re-Survey Medical Board has not been done, this application has been filed. Today when the matter is taken up, learned counsel for the respondents produced before us a letter dated 2<sup>nd</sup> November, 2023 issued wherein in Para 4 and 5 the following communications have been made.

“4. Accordingly, Records The Rajput Regiment vide letter quoted at para 1(b) above processed the case of the applicant with the office of DGAFMS for issuance of sanction for RSMB. IHQ of MOD (Army) vide their letter No 16050/PDC/DGSFMS/MA (Pension)/PM dated 19 Oct 2023 (copy attached) has accorded necessary sanction for conduct of RSMB in respect of No 299791 Ex Hav Pooran Mal. The Indl has informed vide this office letter No. 2997971/DP/PG dated 26 Oct 2023 to report at Base Hospital

Delhi on any working day to conduct his Post Discharge Claim (PDC) medical board.

5. You are requested to apprise facts before the Hon'ble on next date of hearing fixed on 03 Nov 2023 and seek additional time for implementation of the order.”

2. It seems that the letter has been recently issued and based on the letter the individual namely the applicant herein has been invited on 26<sup>th</sup> October, 2023 to report to Base Hospital, Delhi on any working day to conduct the Post Discharge Claim medical board.

3. In view of the above, the applicant is directed to report to Base Hospital Delhi. On applicant appearing the Base Hospital Delhi along with a copy of the letter dated 2<sup>nd</sup> November, 2023 and communication dated 19<sup>th</sup> October, 2023, namely, sanction order produced before us, the in charge of the Base Hospital Delhi shall conduct the medical board and submit the report to the competent authority for proceeding in the matter. Let the entire exercise be undertaken within four weeks.

4. List again on 18<sup>th</sup> December, 2023.

5. Let a copy of this order be provided *DASTI* to learned counsel for the parties.
