3. During the pendency of these matters, it is stated by learned counsel for the applicants that both the applicants have been granted Permanent Commission and, therefore, he seeks withdrawal of OA 22/2022 and OA 164/2022.

4. In view of the statement of learned counsel for the applicants both OA 22/2022 and OA 164/2022 with MA 153 and 154/2022 are dismissed as withdrawn. OAs stand disposed of.

**OA 718/2022 WITH MA 993/2023**

5. On instructions, learned counsel for the applicant submits that the applicant in this case has expired as she sustained certain injuries in an accident. As the applicant is claiming grant of Permanent Commission, after her death, the claim would not survive and, therefore, we dispose of the matter having been abated.

6. However, in case, with regard to terms and conditions of the contract of service, the surviving legal representatives of the

deceased applicant have any legal claim still subsisting, the liberty shall be available to them to initiate legal proceedings in accordance with law.

7. The OA is disposed of as having been abated.

**OA 287/2022 WITH MA 5460/2023**

8. This matter is being heard with the bunch of other women officers claiming Permanent Commission. A submission is made today on behalf of the applicant to the effect that the applicant seeks to withdraw the OA for the present since she is seeking release from service and due to pendency of the OA, her release application is not being processed. It is prayed that the OA be dismissed as withdrawn and subsequently, depending upon the orders to be passed on her release application, if required, she may be granted liberty to invoke the jurisdiction of this Tribunal.

9. In view of the above the OA 287/2022 with MA 5460/2023 is dismissed as withdrawn with the liberty aforesaid.
