A mention was made by ShriPandey with regard to the O.A. No. 2807/2021 and other cases listed in the general Notification section of the cause list of today from Sl. Nos. 19 to 63. Counter affidavit has been filed in the lead matter being O.A. No. 28 of 2022. All these matters have to be heard finally. ShriPandey submits that he shall be filing his rejoinder during the course of one week. He requests that in view of the urgency in the matters, the date of hearing of these cases may be preponed to any date in the month of December, 2022 and the date already fixed by the office in the Notification list i.e. 24<sup>th</sup> January, 2023 may be changed.
