There is a dispute with regard to the calculation of the benefit to be granted to the applicant. Rival contentions have been raised and calculation statement has been filed. To adjudicate the rival contentions and the statement of the claim, we cannot exercise our jurisdiction under Section 19 of the Armed Forces Tribunal Act, 2007, and determine in an

execution proceeding under Section 29 of the Armed Forces Tribunal Act, 2007, in conjunction with Rule 25 of Armed Forces Tribunal (Procedure) Rule, 2008. The powers available to this Tribunal under Rule 29 are akin to execution of a decree passed by a Court of Civil Jurisdiction in dealing with a civil suit and if fresh disputes arise in the implementation of a decree it has to be adjudicated in accordance with law and the power for execution available cannot be exercised. That being so, we grant liberty to the applicant to challenge the calculation and the benefit conferred to him in accordance with law before an appropriate forum.

2. In view of the aforesaid, CA and all MAs listed today stand disposed of.

3. If the applicant, so advised, may raise the dispute with regard to the calculation by way of filing a separate application under Section 14 of the Armed Forces Tribunal Act, 2007, in accordance with law.
