After the order passed on 12.05.2023, it is reported that neither the respondents have supplied any documents/ affidavits nor have they filed it.

2. On the contrary, in response to MA 1528/2023 filed in OA 2167/2021, MA 1385/2023 in OA 2008/2021, MA 1379/2023 in OA 1965/2021 and

MA 910/2023 in OA 1303/2019, it is stated that the respondents have filed detailed replies/ objections to the MAs and the reasons indicated in the same pertaining to the submission of documents and other details of the applicants.

3. The applicants have received the copies of the replies in the aforesaid MAs and are granted liberty to file their affidavit in rebuttal or rejoinder within two weeks.

4. In cases where the replies have not been filed, the same shall be filed within a period of one week from today and copies supplied to each of the applicants who is appearing in those cases.

5. The matter be now listed on **28th August, 2023** at **2:15 pm** for final hearing.

6. It is made clear that hearing shall continue on each day after **28th August, 2023** at **2:15 pm** till conclusion. That apart a complaint was made by Shri I.S. Singh, learned counsel for the applicant in OA No. 2215/2021, that he has not even received the original counter affidavit/ objections filed by the respondents after

remarks from the Hon'ble Supreme Court. If that be so, the same be supplied to him within one week.

7. That apart, in any of the cases if the counsel see that the counter affidavit filed by the respondents, after remarks, have not been supplied, they may make a request to counsel for the respondents who shall give it to them within one week.

9. Respondents are further directed to produce the original relevant records at the time of final hearing for the perusal of the Tribunal.

10. A copy of this order be provided '**DASTI**' to learned counsel for both the parties.
