All these matters are listed today in pursuance to the order passed by this Bench on 7<sup>th</sup> December, 2022 based on the remand order passed by the Hon'ble Supreme Court on 20<sup>th</sup> October, 2022 in Civil Appeal No. 841-843/2022 **Cdr Amit Kumar Sharma Vs UOI & Ors**, we had from para 3 onwards of our orders directed the respondents to file additional affidavits indicating the facts not only mentioned and observed by the Hon'ble Supreme Court in order passed on 20<sup>th</sup> October, 2022 but also the specific directions issued by us from para 3 onwards in the order passed by us on 07.12.2022.

Today, we are informed in view of the case where Gp Capt Karan Singh Bhati is represented, he has filed counter affidavit, so-called affidavit and in all other cases the affidavits have been given to the respective counsels for their filing. However, based on the counter affidavits that have been filed, Shri Pandey points out to us that the affidavits do not meet the requirement of the remand order passed by the Hon'ble Supreme Court and also the specific directions

issued by this Tribunal on 7<sup>th</sup> December, 2022. We request Gp Capt Karan Singh Bhati, Sr. CGSC to go through this aspect of the matter and ensure that the additional counter meet all the requirements as are discussed hereinabove and indicates there is any short coming, the same is rectified and further additional affidavit filed.

We direct that all the counter affidavits directed hereinabove should be filed by the respondents on or before 3<sup>rd</sup> April, 2023 with copy to each of the counsel representing the applicant and the matter be now listed on **6<sup>th</sup> April, 2023** at 2.15 PM for further orders.
