In the matter of production of documents and various other issues as detailed in the order passed by this Tribunal on 29th August, 2023, the respondents have filed two additional affidavits and the same are taken on record along with documents /detailed chart.

2. In response to the same, Ms. Pooja Dhar, Advocate appearing for some of applicant has filed a reply in the form of a counter affidavit and has tried to demonstrate that respondent have not complied with the directions issued by the Hon'ble Supreme Court and by this Tribunal on 29th August, 2023 and the information and documents supplied are not sufficient enough for the applicants to address the issue with regard to the points indicated by the Hon'ble Supreme Court in the remand order.

3. We grant two weeks' time to respondents to respond to the objections raised by the applicant.
