2. It is essential to observe that the grievance of the applicant beyond the change of the name of the wife to **Sughandi K.**, was also in relation to his own name having been misspelt as V.R. Mohana Rama Karishnan, which the applicant sought ought to be read as **V.R. Mohana Rama Krishnan**. In relation thereto the attention of the applicant is drawn to Para 3 of this letter dated 03.02.2025 which is to the effect:-

“3. It is requested to raise service profile request on SPARSH (System for pension Administration (RAKSHA) by using SPARSH ID and password. To initiate profile service request, go to manage profile and raise a request for change of data by uploading this NE POR and submit the case. By submitting your request, a system generated token number will be allotted. After verifying your request by DAV/O/o Jt CDA(AF)/O/o PCDA(P), corrigendum SPARSH PPO will be notified.”

3. Counsel for the applicant has submitted that the applicant has made an attempt to login to put forth his change of name which he is unable to do so and submits that he shall make an attempt again. Costs as imposed vide order dated 07.10.2024 be also paid by the respondents on the next date of hearing.

4. The matter be re-notified for hearing on **14.07.2025**.
