## ORDER 24.02.2025

#### OA 2048/2024

A weeks time is sought by the respondents to file the counter affidavit, which be so filed accordingly. Costs as imposed vide order dated 05.02.2024 in WP (C) 489/2023 have not been paid by the respondents.

2. It is submitted on behalf of the respondents that the said costs were imposed vide proceedings dated 05.02.2024 in WP (C) 489/2023 of a sum of Rs. 5000/~ in view of the non filing of the counter affidavit therein vide order dated 15.05.2024 in the said writ petition, in view of the liberty granted to the petitioner

thereof i.e the applicant herein to seek redressal before the AFT, such costs would be deemed to be waived.

In view of the factum that the proceedings in the matter are pending from the date 03.07.2024 and the counter affidavit has not been filed and vide direction dated 20.09.2024, the counter affidavit had been directed to be filed with the costs as imposed in WP(C) 489/2023, the said counter affidavit permitted to be filed within a week herein above is directed to be filed along with the payment of the costs as directed by the said order 20.09.2024. The prayer made that the said costs are not to be paid cannot be accepted.
