The applicant vide the present OA makes the following prayers :-

“8(a) Direct Respondents for correct the date of birth as 18-02-1976 as per Matriculation Examination Certificate (Annexure A-2) instead of 12-03-1980 as the question involved in this case is no longer res integra, as the same had already been settled by Hon'ble High Court of Punjab and Haryana in the cases of of Azad @ Ismail Versus State Of Haryana [CRM-M No. 45406 of 2022 (O&M) date of decision 17.02.2023 by Hon'ble Punjab and Haryana High Court] (Annexure A-3) and presumption and determination of age has been defined in section 94 of the "THE JUVENILE JUSTICE (CARE AND PROTECTION OF CHILDREN) ACT, 2015 (Annexure A-4).

(b) Any other relief which the Hon'ble Tribunal may deem fit and proper in the fact and circumstances of the case.

(c) Award cost of the OA to the applicant.”

2. On behalf of the respondents, pursuant to proceedings dated 19.12.2024 has been submitted copy of document dated

06.02.2025 issued by OIC Legal Cell for OIC Records to the Legal Cell of the Armed Forces Tribunal, Principal Bench, New Delhi alongwith document no. 13697835N/C-2/Lib-NE dated 21.01.2025 which indicates the publication of the Part II order in relation to the new date of birth of the applicant's wife Smt. Satpal Kaur, now reading to the effect as 18.02.1976 in place of 12.03.1980.

3. The prayer made by the applicant was in relation to the said aspect alone. In view of the publication of the Part II order dated 21.01.2025 copy of which has been submitted on behalf of the respondents by the learned counsel for the respondents, the OA is disposed of, with directions to the respondents to issue the requisite Corrigendum PPO with the date of birth of the applicant's wife Smt. Satpal Kaur wife of Ex LNK Satnam Singh with a date of birth being 18.02.1976 which Corrigendum PPO be issued within a period of two months from the date of this order.

4. Thus, the OA 1896/2024 is disposed of.
