In pursuance to the order passed on 30<sup>th</sup> August, 2024, Mr. Ajit Kakkar, learned counsel for the applicant, informs us that the cases of the applicants in OA Nos.3510, 2684 and 2509 of 2023 for premature discharge were considered in the Board held in September 2024 and all the three applicants have been granted premature retirement. That being so, as far as OA No.3510/2023 (Wg Cdr Sahil Bajaj); OA No.2684/2024 (Wg Cdr Harsh Vardhan Pandey) and OA No. 2509/2023 with MA 3578/2024 (Sqn Ldr Bristow Thankachan) are concerned, they are disposed of as having been rendered infructuous in view of the relief granted by the respondents.

2. So far as applicant in **OA 2033/2024 with MA 4554/2024** (Wg Cdr George Joseph) is concerned, it is informed that his case will be considered in the Board to be held in December 2024, therefore we direct that **OA 2033/2024 with MA 4554/2024** be listed on **18<sup>th</sup> December, 2024**.

3. As far as applicants in **OA No.1356/2023** (Wg Cdr Piyush Kumar) and **OA No.3034/2023** (Sqn Ldr Tushar Bisht) are concerned, it is indicated that even though their cases were considered in the Board which was held in September 2024, but they have not been granted premature discharge. Respondents are directed to indicate as to why premature discharge in the case of these two applicants has not been granted so that the matter can be decided on merit on the next date. That apart, the respondents should also inform us as to what action has been taken in the case of **Sqn Ldr Tushar Bisht**, applicant in **OA 3034/2023**, in the matter of resignation from commission submitted by him and also the action taken by the respondents on his resignation application.

4. List **OA No. 1356/2023** and **OA No.3034/2023** on 6<sup>th</sup> November, 2024.
