ORDER 30.09.2024

MA 1994/2024 had been filed on behalf of the applicant on 06.05.2024 with the following prayers:

- "A. To conduct the Post Discharge Medical Board in respect of the applicant and assess the percentage of disabilities ID Primary Hypertension and Anxiety Disorder as per the Entitlement Rules 2008.
- B. To pass such direction as deemed fit by the Hon'ble Tribunal in the facts and circumstances of the case."
- 2. Vide order dated 15.09.2023 in OA 1823/2020 it had been directed to the effect:

"Thus, in view of the provisions of Para-8(a) of the Entitlement rules for Casualty Pensionary Awards to Armed Forces Personnel, 2008, the OA is disposed off with directions to the respondents to conduct the Post Discharge Medical Board for assessment of the disabilities that the applicant claims that he suffers from, within a period of three months of the receipt of copy of this order. The impugned letter no. Air

HQ/99801/5/764186/DAV(Med) dated 19.08.2020 is also set aside."

3. The respondents on 10.05.2024 sought time to make submissions to ascertain the status of the Post Discharge Medical examination to be conducted in terms of the order dated 15.09.2023 in OA 1823/2020 and the matter was thus notified for hearing to the date 31.05.2024. On 31.05.2024, the respondents submitted copy of a document dated 08.02.2024 to submit to the effect that the Post Discharge Medical Board was conducted on 12.04.2024 and thus would be governed by the GMO, 2023. The attention of the respondents vide order dated 31.05.2024 was drawn to the letter dated 29.04.2024 bearing of the Brig **AFMS** Pension 16036 no. RAMB/RMB/DGAFMS/MA/Pension GMO and the said letter reads to the effect:~

"Clarification on Applicability of GMO 2023 & ER 2023

1.Ref this office letter No. 16036/RAMB/
IMB/DGAFMS/MA(Pens) GMO dt. 19 Oct 2023 and
Ministry of Defence, Dept of Ex-Servicemen Welfare note
no. 16(3)/2023/D(Pen/P0l)/Vol-ii dt 21 Sep 2023 (Copy enclosed.)

2. The amendment in Para 3 of our letter under ref is fwd herewith for your further necessary action:

<u>For:</u> It is once again reiterated that GMO, 2023 is applicable prospectively for all the medical boards of serving personnel (Offr, JCOs & Ors) conducted after 21 Sep 2023 as GMO 2008 was in vogue prior to date of promulgation of GMO, 2023 Appeals and Review Medical Boards pertinent to veterans would

be conducted based upon the GMO relevant at the time of Release Medical Board.

Read: It is one again reiterated that GMO, 2023 is applicable prospectively for all the medical boards of serving personnel (Offrs, JCOs & Ors) conducted on and after 21 Sep 2023 as GMO 2008 was in vogue prior to date of promulgation of GMO, 2023. Appeals and Review Medical Boards pertinent to veterans would be conducted bases upon the GMO relevant at the time of Release Medical Board."

- 4. Despite the same on 06.08.2024, the respondents have placed on record a copy of the letter no. 16050/DGAFMS/MA(P)/MK dated 03.07.2024 which reads to the effect:~
 - " CLARIFICATION ON APPLICABILITY OF GMO 2023 POST DISCHARGE CLAIM (PDC) MEDCIAL BOARD ON COURT ORDER 764186-R EX-SGT MUKESH KUMAR, PMF (E)
 - 1. Ref your letter No Air HQ/99801/5/DAV (Med) dt 27 Jun 24.
 - 2. It is reiterated that GMO 2023 is applicable to all cases of death/disability recorded on or after 21 Sep 2023 as per our letter No. 16036/RAMB/IMB/DGAFMS/MA (Pens) dt 29 Apr 24.
 - 3. In the instant case veteran was discharged from service in SHAPE-I and hence did not undergo any Release Medical Board for the impairments addressed in the Post Dicharge Claim (PDC) Medical Board. The first instance of recording of impairments was at the time of conduct of PDC Medical Board which was carried out on 03 May 24 which is after the promulgation of GMO 2023 on 21 Sep

23. Accordingly GMO 2023 is applicable in the instant

case.

4. This is for your info and necessary action."

Taking into account the factum that the order dated 5.

15.09.2023 in OA 1823/2020 related to the disability that the

applicant professesed had occurred within a period of seven years

from the date of his discharge, with his discharge having been on

07.07.2016, it is apparent that it is the GMO (Military Pensions)

2008 that shall apply to the instant case and not the GMO

(Military Pensions), 2023 which takes effect after 21.09.2023.

6. The directions dated 15.09.2023 in OA 1823/2020 with

compliance thereof, for conducting the Post Discharge Medical

Claim brought in terms of the GMO(Military Pensions) 2008 be

complied with by the respondents without default within a period

of four weeks from today and the compliance report be placed on

the record by the respondents.

7. The matter be re-notified for hearing on 11.11.2024.

8. Copy of this order be given *DASTI* as prayed.
