ORDER 24.07.2024

MA 2846/2024 has been filed by the applicant on 18.07.2024 seeking implementation of the order dated 13.04.2023 in OA 1979/2021 whereby vide paragraphs 6 & 7 thereof, it was directed to the effect:-

"6. In view of the aforesaid judicial pronouncements and the parameters referred to above, the applicant is entitled for disability element of pension in respect of disability Primary Hypertension (Old)! Accordingly, we allow this application holding that the applicant is entitled to disability element of pension @ 30% rounded off to 50% with effect from the date of his discharge in terms of the judicial pronouncement of the Hon'ble Supreme Court in the case of Union of India Vs. Ram Avtar (Civil Appeal No. 418/2012), decided on 10.12.2014.

7. The respondents are thus directed to calculate, sanction and issue the necessary PPO to the applicant within a period of three months from the date of receipt of copy of this order and the amount of arrears shall be paid by the respondents, failing which the applicant will be entitled for interest @6% p.a. from the date of receipt of copy of the order by the respondents."

2. The records of OA 1979/2021 indicate that there has been

no prayer made by the respondents seeking grant of leave to

appeal against the said order within the stipulated period of time

in terms of Section 31 of the AFT Act 2007.

3. Despite a year having elapsed from the date 13.04.2023

when the directions in OA 1979/2021 were issued there has

been no compliance by the respondents. Whilst accepting notice

of the present application MA 2846/2024 the respondents

submit that they intend to assail the order 13.04.2023 in OA

1979/2021, by filing a writ which they are entitled to do so, if

permissible in accordance with law.

4. In the event of there being no stay order of the operation of

the order dated 13.04.2023 in OA 1979/2021 being placed on

the record by the respondents for the next date of hearing, the

affidavit of the compliance of the said direction with a demand

draft of sum of Rs. 75,000/~ in the name of the applicant for

payment of costs be placed on the records by the respondents.

5. Re-list the matter on **23.08.2024**.

6. Copy of this order be given *DASTI* as prayed.
