ORDER 14.11.2024

MA 4400/2024 has been filed by the applicant seeking implementation of the order dated 18.03.2024 in OA 907/2024 whereby vide Para 11 thereof, it was directed to the effect:

- "11. The OA 907/2024 is thus allowed and the respondents are directed as under:-
- (i) Calculate the pension of the applicant based on the last held rank by him before retirement i.e. Junior Warrant Officer, and in consonance with the principles of calculation that have been upheld in JWO Gopalakrishnan in this regard; and
- (ii) The applicant will be accordingly issued a fresh Corrigendum
- PPO in the last rank held by him within two months and the arrears paid accordingly, failing which, it shall carry interest @6% till actual payment."
- 2. On behalf of the respondents whilst accepting notice of the MA 440/2024 it is submitted that they do not intend to assail the order of which implementation is sought and it is submitted that the grant of the arrears in terms of the order dated 18.03.2024 in

OA 907/2024 be confined to commence to run from a period of

three years prior to the institution of OA 1387/2024.

3. Inter alia reliance is placed on behalf of the respondents on

proceedings dated 04.09.2024 in MA 2853/2024 in OA

1387/2024 in similar circumstances whereby the grant of the

arrears of pension as revised for the last rank pension of the

applicant were confined to commence to run from a period of

three years prior to institution of the said OA.

4. In terms of the directions of the Hon'ble High Court of

Delhi in WP(C) 6815/2024 dated 23.07.2024, thus as an interim

measure till disposal of WP(C) 6815/2024 now listed before the

Hon'ble High Court of Delhi for the date 17.12.2024, the grant of

the arrears of revised pension for the last rank pension of the

applicant are confined to commence to run from a period of three

years prior to the institution of the OA 907/2024 instituted on

05.03.2024.

4. The matter be re-notified for hearing on 24.01.2025.
