## ORDER 22.07.2025

On behalf of the respondents has been submitted a copy of Letter No. 4262123X/CC/X/NE dated 21.07.2025 whereby vide Para 2 it is stated to the effect:-

- "2. It is reiterated that relief sought by the applicant has already been granted by Principal Controller Defence Accounts (Pension), Prayagraj vide Pension Payment Order No. 213200600587 corrigendum No 7 dated 06 Feb 2024 (copy att.). Arrears Rs. 4,14,907/~ (Rupees Four lakh fourteen thousand nine hundred seven only) on account of grant of MACPs for Nb Sub grade as reflected in the said PPO has been paid through SPARSH (Pension Slip for Feb/2024 att)."
- 2. A copy of the pension slip for February 2024 has also been supplied on behalf of the respondents. The same is taken on

record, copy thereof has also been supplied to the learned counsel for the applicant.

3. In as much as the prayers made by the applicant vide the present OA were to the effect:-

"(a) Direction to the respondent to grant the service benefits of Modified Assured Career Progression Scheme of the rank of Nb Sub of ₹ 4,200/- Grade Pay with effect from 23-10-2006 (on completion of 24 years) to till 31-10-2006 (date of retirement) and after that pensionary benefits of Nb Sub Grade Pay as applicant served more than 24 years of continuous regular service (24 years and 9 days) with all consequential benefits with interest @12% per annum till its actual payment and applicant case is squarely covered and is no more res integra in the case of Union of India & Ors. vs. Balbir Singh Turn & Anr. Civil Appeal Diary No. 3744 of 2016 where 25 more Civil Appeals were tagged judgment dated 08.12.2017. Based on the above judgment, respondents circulated letter dated 25.07.2018 (Annexure A-7) and 10.08.2018 (Annexure A-8) for grant of MACPs wef 01.01.2006.

(b) Direction to the respondent to omit/delete the words continuous regular which arbitrary added in para 2 of Ministry of Defence letter dated 30.05.2011 (Annexure A6), which is contrary to the condition set out as in Gazette and policy as mentioned in (Annexure A-4 & A-5) of present OA as word is only service not words continuous regular service.

(c) The applicant be granted any other which this Hon'ble

Tribunal may deem appropriate, just and proper in the interest

of justice and in the facts and circumstances of the case.

(d) Award cost of the OA to the applicant"-

in view of the document dated 21.07.2025 with averments made

in Para 2 thereof reproduced hereinabove, it is apparent that the

prayers made by the applicant already stand redressed, the

OA 3298/2024 calls for no further action and is disposed of

accordingly.
