- 2. The rejoinder, if any, thereto be filed by the applicant within a period of four weeks. List the matter before the Principal Registrar on 13.11.2023 for completion of pleadings and before the Bench thereafter.
- 3. Counsel for the respondents in OA 1135/2016 submits that in terms of proceedings dated 08.05.2018, all submissions made on behalf of the respondents in OA 223/2016 are adopted.
- 4. It is also submitted by the learned counsel representing the respondents in OA 1901/2020 that as submitted on 22.02.2023 in the said OA the respondents seek to adopt the counter affidavit filed in OA 223/2016 by the respondents even in the instant matter.
- 5. it is at this stage pointed out on behalf of the respondents that MA 2189/2020 which was allowed vide order dated 14.12.2020 was only filed in OA 223/2016 whereby the applicant had sought time to incorporate amendments into the prayer clause in the said OA and it has thus been submitted on behalf of the respondents that they have not been served with the amended OA, if any, in relation to other matters apart from OA 223/2016.

6. Counsel for the applicant submits that the amendment would be sought in all the connected matters and an application in relation thereto would be filed. As and when the same is filed, the same be listed.

7. It is pointed out on behalf of the respondents that OA 223/2020 listed at serial no. 23 for the day along with the connected matter has been erroneously tagged along with OA 223/2016, which submission is apparently correct on a bare perusal of the records of OA 223/2020, which indicates that the prayer made therein relates to the grant of the disability pension, whereas the prayer made in the lead case in the connected matters in OA 223/2016 is *qua* fixation of pay scale and grade pay. OA 223/2020 is thus directed to be de-tagged from the OA 223/2016 and matters connected therewith and OA 223/2020 with its connected matters is directed to be re-notified for final hearing on **08.12.2023**.
