MA 5470/2024 has been filed by the applicant seeking implementation of the order dated 30.05.2023 in OA 1951/2021. Notice thereof is issued to the respondents. Whilst accepting notice, on behalf of the respondents has been submitted a copy of communication of the letter dated 12.09.2023 to state to the effect:-

“2. In the above context, it is stated that while review of the pay fixation of the applicant it has been observed that on promotion of the applicant to the rank of Maj with effect from 09.06.2007, his pay had already been fixed @ Rs 24,420/- + 6,600/- (Grade Pay) by giving him benefit of switching over to the Sixth CPC from the date of promotion itself. Similarly, on promotion of the applicant to the rank of Lt Col also his pay has already been fixed in the most beneficial manner. This may be seen from the details of pay fixation carried out as tabulated below:-
