3. Respondents submit that in all these three cases they are adopting the counter affidavit filed by Union of India in the case of Maj Suvalakhmi Borgohain (OA 28/2022). Judicial notice can be taken note of the fact that the aforesaid case has been heard and reserved for judgment however along with the adopting affidavit filed in OA 3677/2023 a true attested copy filed in the OA 28/2022 has not been annexed. Respondents are granted a week's time to annex the counter affidavit filed in OA 28/2022 along with the adopting counter affidavit.

4. In OA 3403/2023 it is stated that the adopting counter affidavit has been filed but the same is not on record. Respondents to check with the registry and ensure the defects, if any, be rectified and the same be brought on record. Learned counsel for the respondents prays for and is granted four weeks' time to file or adopt the counter affidavit in OA 4054/2023.
