Vide order dated 28.05.2025, a bailable warrant in the sum of Rs. 5,000/- was directed to be issued against the Branch Manager, CPPC, PNB Link Office (Pension), 1st Floor, Gurudwara Road, Karol Bagh, New Delhi-110008.

2. From the office note dated 03.06.2025, it is seen that the bailable warrant was served on the Officer-in-Charge, Police Station Karol Bagh, New Delhi on 16.07.2025 for being served on the Branch Manager CPPC, PNB Link Office (Pension), 1st Floor, Gurudwara Road, Karol Bagh, New Delhi-110008. However, despite service of the warrant, it has not been executed and no execution report has been submitted by the concerned officer of Police Station Karol Bagh Ajmal Khan Road, Karol Bagh, New Delhi-110005.

3. Today, when the matter is taken up, neither the Branch Manager of the Bank appeared nor any report submitted by the

officer-in-charge of Police Station Karol Bagh Ajmal Khan Road, Karol Bagh, New Delhi-110005 regarding service of theailable warrant or submission of the bail bond by the Branch Manager is available on record.

4. In view of the above lapse, a freshailable warrant in the sum of Rs. 5,000/- is hereby directed to be issued against the Branch Manager CPPC, PNB Link Office (Pension), 1st Floor, Gurudwara Road, Karol Bagh, New Delhi-110008. The warrant shall again be sent to the Officer-in-Charge, Police Station Karol Bagh Ajmal Khan Road, Karol Bagh, New Delhi-110005 for its execution returnable on **27.08.2025**.

5. A copy of this order along with relevant documents be also forwarded by the office to the Commissioner of Police, New Delhi, highlighting the lapses on the part of the authorities of Police Station Karol Bagh Ajmal Khan Road, Karol Bagh, New Delhi-110005 in non executing theailable warrant issued by this Tribunal.

6. List again on **27.08.2025** as **Part Heard**.
