Though an additional affidavit dated 17.10.2023 has been filed on behalf of the Indian Air Force with it having been stated therein to the effect :-

*“5. That it is respectfully submitted that there is no provision in the Pension Regulation for the Air Force, 1961 (Pt-1) a kin to para 61 of the Pension Regulation for Army, 2008 (Pt-1). It is also submitted that the term “boy” mentioned in para 61 of the Pension Regulation for Army, 2008 (Pt-1) is not all mentioned in the Pension Regulation for Air Force,*

*1961 (Pt-1) and there is no person appointed as boys in the Indian Air Force.”*

and placed on record with the said additional affidavit at Annexure R-4 is the Govt. of India, Policy letter No. 12(06)/2019/D/(Pen/Pol) dated 16.07.2020, time is sought by the learned Sr. CGSC Mr. A K Gautam to place on record the affidavit for reconciliation of the same by all the three services in relation to the aspect detailed vide order dated 16.08.2023 with reference to Para 61 in Chapter III of the Defence Service Regulations, Pension Regulations for the Army (Part-I), 2008 which reads to the effect :-

*“61. Recruits and boys will be eligible for invalid gratuity at the relates and under conditions applicable to Sepoy of lowest group.”,-*

which be so filed within a period of four weeks.

The matter be re-notified for hearing on **24.05.2024**.
