Heard and perused the record.

By way of the present application, the Applicant has challenged the discharge order dated 18-06-1973 which was intimated by Air Force Record Office vide letter dated 28-07-1993 and order dated 25-05-1993 by which his representations were rejected.

A perusal of the record reveals that Applicant was discharged on 18-06-1973 against which he filed first writ petition bearing no. 46381/1992 before the Hon'ble Allahabad High Court which was partly allowed by the Hon'ble Allahabad High Court vide order dated 03-12-1992 and Respondents were directed to dispose of the representations of the Applicant within four months from the date of receipt of certified copy of the court order. As per direction, Respondents vide order dated 25-05-1993 disposed of the representations of the Applicant and the same were rejected. Being aggrieved from the said order dated 25-05-1993, Applicant preferred his second writ petition bearing no. 29090/1993 before the Allahabad High Court which was dismissed by the said court vide order dated 26-09-1995.

Applicant, against the order dated 26-09-1995 of the Hon'ble Allahabad High Court, approached the Hon'ble Apex Court vide Special Leave Petition bearing no. 18616 of 1996, however the same was dismissed vide order dated 28-08-1996. Further Applicant filed a review petition bearing no. 2035 of 1996 before the Hon'ble Supreme Court which was also dismissed vide order dated 27-11-1996.

With the main application, Applicant has also filed an application under Section 22 of the Armed Forces Tribunal Act, 2007 read with Section 5 of the Limitation Act 1963 seeking condonation of delay in filing the original application before this Tribunal.

We have considered submissions of the learned counsel for the Applicant and also gone through the record. Considering the facts of the case, we, at this belated stage, do not find any ground to entertain the present application as the matter has already been agitated before the Hon'ble Allahabad High Court and Hon'ble Supreme Court of India. Hence, application stands dismissed. File be consigned to the Record Room. No order as to costs.
