MA 1929/2019 and MA 1930/2019 :

The respondents seek condonation of 16 days' delay in filing the reply to the OA vide M.A .No. 1929 of 2019. Through M.A. No. 1930 of 2019, condonation of 16 days' delay is sought in filing the reply to M.A. No. 1192 of 2019. Allowed as prayed for and delay stands condoned.

M.A. Nos. 1929/2019 and MA 1930/2019 stand disposed of accordingly.

MA 1192/2019 in OA 611/2019 :

Not only learned counsel for the respondents has raised objection vis. a vis. territorial jurisdiction to entertain the instant OA, even otherwise the grounds carved out for condonation of delay of 363 days in filing the accompanied OA have been strongly opposed.

After considering the totality of the facts and circumstances of the present case coupled with the fact that the statutory complaint dated 01.02.2017 moved by the applicant against his non-empanelment for promotion to the rank of Brigadier by No.2 Selection Board (Fresh) held in November, 2015, which has been rejected by the Ministry of Defence vide Order dated 20.09.2017, impugned herein, both the objections raised by learned counsel for the respondents carry no weight. Hence, application is allowed.

Resultantly, delay is condoned in filing the accompanied OA.

M.A. No. 1192 of 2019 stands disposed of accordingly.
