For the averments made in these applications, the delay in filing the counter affidavits is condoned. The counter affidavits are taken on record. Both the MAs stand disposed of.

OA Nos. 1862, 2736 AND OA 3418/2023

2. Counter affidavits in these three matters have been filed. Rejoinder, if any, may be filed within four weeks.
3. In OA 1862/2023 the prayer made by the applicant vide para 8 (a) reads as under:

“(a) Direct the respondents to place on record answer sheets of all examination and re-examination of the applicants from A to E term along with attendance sheets.”

4. It is stated by learned counsel for the applicant that neither in the counter affidavit nor in the documents filed; this issue has been addressed by the respondents. Respondents to take note of the same and address this issue or file their objections on or

before the next date. If advised, they may bring the documents on record instead of filing the pleadings.



6. Counter affidavits in these matters have not been filed. Respondents may either adopt the counter affidavits already filed in other connected matters or file a separate counter affidavit within four weeks. Rejoinder, if any, may be filed within two weeks thereafter.

7. List all these matters again on 8th January, 2025 for completion of pleadings.
