MA 3345/2025 has been filed for early hearing of the application. Perused the records. The applicant claims disability pension at the rate of 30% rounded off to 50% w.e.f 03.11.2005 based on the assessment made by the RMB on 28.10.2005 vide Annexure A4. The ailment has been held to be attributed and aggravated due to strain and stress of military service. Inter alia contending that in spite of repeated requests being made for grant of disability as nothing has been granted this application has been filed.


2. On notice being issued the respondents have filed a counter affidavit and in Para 5 of the counter affidavit the respondents make the following submissions:

*"5 That RMB assessed his disability as attributable to service. Being an accepted case, the Air Veteran was sent a set of blank pension paper for completion and submission to this office to process the case for issuance of PPO vide letter No. Air HQ/99798/1/656134/DAV(DP/RMB) dated 11 Jan 2023.*

From the aforesaid it is the case of the respondents that for the purpose of settling the claim of the applicant the information and documents as sought for in the aforesaid paragraph were to be submitted by the applicant and instead of submitting the documents the applicant has filed this OA. The applicant has filed a rejoinder consisting of certain documents collectively filed as Annexure A6. These are copies of the communications dated 27.06.2023 along with a postal receipt and the enclosures therein which according to the applicant are the documents and information which were sought from the applicant by the respondents. In view of the above we direct the respondents to take note of the documents filed by the applicant on 27.06.2023 vide Annexure A6 collectively from page 63 to 89 of the rejoinder and indicate as to what action has been taken on these documents and why the corrigendum PPO has not been issued in spite of submission of these documents.

List the OA again on 27.10.2025.

The MA stands disposed of as we are proposing to dispose of the matter at this stage itself in the motion hearing.
