ORDER 11.08.2025

The applicant IC-56688K Brig Hardip Singh Bhullar vide the present OA filed under Section 14 of the Armed Forces Tribunal Act, 2007 makes the following prayers:

(a) "Call for the Records based on which the respondents most discriminately have fixed the pay of the applicant in the rank of Brig wef 01.12.2021 instead of from the date of next increment i.e. from 01.07.2022, as well as the records based on which the respondents issued the impugned orders thereafter quash all such orders.

- (b) Direct the respondents to fix the pay from the date of next increment from 01.07.2022 consequent to grant of promotion to the rank of Brig on 01.12.2021 instead of fixation of pay and allowances from the date of promotion by quashing the order of such fixation and revise his pay accordingly by granting two increment(Promotion Increment+Annual Increment) on 01.07.2022 and annual increment on 01.01.2024 to the applicant as per Addl. Dte Gen Personnel Services letter dated 23.03.2021 as granted to his batch mates and the juniors.
- (c) Direct the respondents to pay the arrears of the difference of pay accrued upon grant of two increment from 01.07.2022 after adjusting the payments already made alongwith interest @12% from the date it was payable till the date payment is made.
- (d) Pass any other order/orders s deemed appropriate by this Hon'ble Tribunal in the facts and circumstances of the present case."
- 2. The applicant was commissioned in the Indian Army on 09.12.1996 after having been found fit in all respects was promoted to the rank of Capt on 07.12.2000 and to the rank of Major on 16.12.2004. The applicant thereafter was promoted to

the rank of Lt. Col. on 07.12.2009 and to the rank of Col on 04.05.2012 and the Pay Rule-2017 was promulgated w.e.f. 01.01.2016. The Advisory No.11/2021 dated 23.03.2021 was issued by the Addl Dte Gen Personnel Services notifying all Commands that as per the 7th CPC there are two dates for increment on Ist Jan and Ist July of every year depending on the date of appointment or promotion or financial up-gradation. The implications of the said letter are detailed in the Advisory as under:

The applicant has submitted that when he was promoted on 3. 01.12.2021 to the rank of Brig. he was not aware that it would be more beneficial if he would have opted for fixation of pay upon grant of such promotion to the rank of Brig. from the date of next increment i.e. 01.07.2022.

4. The applicant raised his grievances vide letter dated 19.03.2025 to the respondents-Standing Army Pay Commission Section, ADGPS with copy to PCDA(O), Pune regarding difference of one increment from the junior which was replied to vide the impugned order dated 27.03.2025 placed on record as Annexure A-1, it was stated to the effect:

"Ref: Your Letter No.56688 dated on 19.03.2025.

Officer's pay has been compared with batchmated. It is observed that difference in pay is due to that officer has not opted for pay fixation from DNI option while his batch has the opted Please refer to MoD D(Pay/Services) OM No.1(20)/2017/D(Pay/Ser vices) dated 26th February, 2019 which stipulates that Option has to be exercised within three months from the date of promotion to have pay fixed under these provisions from the date of such promotion or to have the pay fixed from the date of accrual of next increment in the scale of the pay in the lower grade. Further, Option for pay fixation on promotion once exercised is final. Also refer ADGPS(PS-3) Dte letter No.B/25451/Doc Pro Offrs/AG/PS-3(D)/02/2021 dated 21 Jun 2021 vide which it was communicated to PCDA(O) that exercising of Option is mandatory through Part II Order with casualty code OPTFXDNI or OPTFXDOP whichever applicable wef 4th September, 2021 duly supported with ink-=signed copy of Option Certificate as prescribed vide GoI MoD New Delhi Letter No.1(26)/97/D(Pay/Services) dated 08.05.2003.

Further officers who had been promoted or granted financial up-gradation on or after 01.01.2016 and desired to exercise/re-exercise option for pay fixation from DNI may opt within three months from the date of issue of GoI MoD New Delhi OM dated 18/08/2023 i.e. by 17 Nov 2023 mandatory through Part II Order as per documentation Procedure duly enclosing the option form and forward through HRMS 2.0 in digital mode. No Option Form and Part II Orders has been received in this office from your side even during this extended time. Officer is requested to liaise through administrative channel for reexercising the option form. ** Letter Approved by AO-Kumar Singh Chandra.**

- 5. Inter alia, it has been stated on behalf of the applicant that the matter is no more res integra in view of the order dated 21.11.2023 of this Tribunal in OA No. 163 of 2022 in the case of Nb Sub/M Tech(B Veh) Brijesh Singh Vs Union of India & Ors.
- 6. A bare perusal of the impugned order dated 13.11.2024 already adverted hereinabove indicates that the respondents have not refuted the contention of the applicant that he was entitled to the grant of next increment from 01.07.2019 after his promotion to the rank of Col. on 06.06.2019. As observed vide order dated 21.11.2023 in *Nb Sub/M.Tech(B Veh) Brijesh Singh vs Union of*

India & Ors. in OA 163/2022 vide Paras 5, 6 and 7 thereof which

reads as under:

- "5. MoD vide its Office Memorandum dated 22.03.2018 (Annexure A-7) had intimated that anyone promoted may opt to have his/her pay fixed from the date of his/her next increment. The relevant extracts are reproduced below:
- 3. After due consideration in this matter, the following is decided as follows:
 - (i) Defence Personnel, who is promoted or upgraded from one rank to another, subject to fulfilment of the eligibility conditions as prescribed in the relevant Recruitment Rules, to another post carrying duties and responsibilities of greater importance than those attaching to the post held by him/her. Such, Defence Personnel may opt to have his/her pay fixed from the Date of his/her Next Increment (either 1st July or 1st January, as the case may be) accruing in the Level of the post from which he/she is promoted, except in cases of appointment on deputation basis to an ex-cadre post or on direct recruitment basis or appointment/promotion on ad-hoc basis, as applicable in the Defence Services.
 - (ii) In case, consequent upon his/her promotion, the Defence Personnel opts to have his/her pay fixed from the date his/her next increment (either 1st July or 1st January, as the case may be) in the Level of the post from which Defence Personnel is promoted, then, from the date of promotion till his/her DNI, the Defence Personnel shall be placed at the next higher cell in the level to the post to which he/she promoted.

(iii) Subsequently, on DNI in the level of the post to which Defence Personnel is promoted, his/her Pay will be re-fixed and two increments (one accrued on account of annual increment and the second accrued on account of promotion) may be granted in the Level from which the Defence Personnel is promoted and he/she shall be placed, at a Cell equal to the figure so arrived, in the Level of the post to which he/she is promoted; and if no such Cell is available in the Level to which he/she is promoted, he/she shall be placed at the next higher Cell in that Level. Illustration:

6. The above details were further clarified and promulgated to the subordinate formations vide Army HQ letter dated 23.03.2021 – "Ex of DNI Option on Promotion" (Annexure A-6). Relevant options are extracted below:

2. As per 7th CPC, there are two dates for increment on 01 Jan and 01 Jul of every year, depending on the date of his appointment or promotion or financial up gradation.

3. The implication of DMA letter above are explained as under:-

It is evident from the details in the letter dated 24.09.2018 (Annexure A-1) that the applicant's date of last increment in the 6th CPC was on 01.07.2015. Thus, as per Para 3 (a and b) of Army HQ letter dated 23.03.2021 (Annexure A-6), on 01.05.2016 and since the applicant was promoted that is between 02nd Jan and 30th Jun and as opted for fixing his pay from the next increments, he is entitled for two increments; one for his promotion and one his annual increment, Jul 2016 and his next annual increment would be due on 01.01.2018."

as the applicant was promoted on 01.12.2021 and opted for fixation of his pay from the next of increment, then he is entitled for two increments i.e. the annual increment and the second accrued on grant of promotion on 01.07.2022 with his next annual increment being due on 01.01.2024.

- 7. The applicant further submits that the actions of the respondents of denial of the revised pay scale to the applicant creating a situation wherein the applicant is being granted basic pay lesser than his batch mates as well as his juniors on a specious plea of putting the onus on the applicant for not submitting the option on promotion in time, despite the obligation on their part to fix the pay of the applicant in a manner which is more beneficial to him, are highly illegal, arbitrary and discriminatory as well as against the mandate of equality and equal pay for equal work and also contrary to the order dated 21.11.2023 of this Tribunal in OA 163 of 2022 titled *Nb Sub/M.Tech(B Veh) Brijesh Singh vs Union of India & Ors.*
- 8. The applicant further submits that the actions of the respondents of denying him, the benefit of fixation of pay in the 7th CPC from the date of next increment (DNI) on grant of promotion/financial up-gradation i.e. on 01.07.2022(two increment(Promotion Increment and Notional Increment) and

granting only promotion increment on 01.12.2021 has resulted in a situation of the applicant getting less pay than his junior on the sole basis of applicant having not exercised the option within the stipulated period of time.

- We have examined numerous cases pertaining to the 9. incorrect pay fixation in 6th CPC in respect of Officers/JCOs/ORs merely on the grounds of option not being exercised in the stipulated time or applicants not exercising the option at all, and have issued orders that in all these cases the petitioners' pay is to be re-fixed with the most beneficial option as stipulated in Para 12 of the SAI 2/S/2008 dated 11.10.2008. The matter of incorrect payfixation and the most beneficial option in the case of JCOs/ORs has been exhaustively examined in the case of Sub M.L. Shrivastava and Ors Vs. Union of India [O.A No.1182 of 2018] decided on 03.09.2021.
- In the light of the above considerations, the OA 10. 2446/2025 is thus disposed of with directions to respondents to the effect:

- a) To fix the pay of the applicant from the date of his next increment from 01.07.2022 consequent to the grant of promotion to the rank of Brig. on 01.12.2021 in the 7th CPC.
- b) On re-fixing his pay in the 7th CPC on 01.07.2022, the applicant be granted two increments' one for promotion(01.07.2022) and the other for annual increment(01.01.2024).
- c) His subsequent pay be recalculated accordingly.
