The applicant vide the present OA makes the following

prayers:~

"8. RELIEF(S) SOUGHT: ~

In view of the facts and circumstances mentioned above and the submissions made at Paras 4 and 5 of this OA, the Applicant most humbly prays that this Hon'ble Tribunal may be pleased to allow the present Application (OA) by passing the following orders and directions: ~

- (a) Declare that the martyrdom of the Applicant's husband during First Indian Army Mountaineering Expedition to Mount Makalu (8485 mtrs)/ 2019 in Nepal' shall be treated as 'Battle Casualty' in terms of AO 5/2020/MP r/w AO 01/2003/MP;
- (b) Direct the Respondents to award 'Battle Casualty status to the Applicant's husband in respect of aforesaid death and grant him all consequential benefits as may be due to a Battle Casualty case under the extent Govt policy/notifications;
- (c) Issue any other order(s) and direction(s) as deemed appropriate by this Hon'ble Tribunal under the facts and circumstances of this case."

2. A perusal of the averments made in the OA itself vide para 6 indicates that it read to the effect:~

"6. DETAILS OF REMEDIES EXHAUSTED: That other team members of the same expedition team submitted a Representation dt 21.10.2024 addressed to the office of Respondent No.3.",_

it is thus categorically stated therein in the said OA itself that other team members of the same expedition team submitted a representation dated 21.10.2024 addressed to the respondent no 3, to which there has been no response.

- 3. There is nothing to indicate that the said representation dated 21.10.2024 was made by the applicant thereof on any authority from the applicant herein.
- 4. In the interest of justice, however, we direct that the present OA is treated as a representation of the applicant herein by the respondents who are directed to dispose of the same within a period of six months from today. The applicant, if aggrieved, thereafter would be entitled to seek redressal as per law.
