In view of the counter affidavit that has been filed on behalf of the respondents whereby vide Para-3, it has been stated to the effect:-

"3. That it is submitted that consequent upon dismissal of Civil Appeal Diary No 3744 of 2016 filed by UOI Vs Balbir Singh Turn & Others by the Hon'ble Supreme Court vide their Order dated 08 Dec 2017, competent authority vide their letter No 14(1)/99 D (AG) dated 25 Jul 2018, has issued amendment to the policy making the benefits admissible with effect from 01 Jan 2006. Accordingly, occurrence regarding 3rd MACP (Hav Grade) with effect from 01 Jan 2006 in respect of applicant has been published vide EME Records Part-II Order No 1/4340/0029/2018 accordingly PCDA (P) Allahabad has notified corrigendum PPO of 3rd MACP (Nb Sub Grade) vide e-PPO no 188200701272 with suffix 0109 dated 13 Sep. 2019 and the same has already forwarded to the Chief Manager, CPPC, Chandni Chouk, New Delhi and his PDA with copy to the Applicant vide EME Records letter No 14541809F/SP (Rev)/MACP/Pen dated 19 Dec 2019. The competent authority has

issued amendment to the policy making the benefits admissible with effect from 01 Jan 2006 and action for grant of benefits to the Applicant has already been taken, in original interest as the relief sought has already been granted to the Applicant vide e-PPO noted above."

and taking into account, Annexure R-2 placed on record, counsel for the applicant submits that the OA may be disposed of accordingly.

2. In view of the averments made in the counter affidavit of the respondents which state specifically to the effect that the applicant has already been granted MACP benefits vide the letter no. 14541809F/SP(Rev)/MACP/Pen dated 19 Dec 2019, the OA 674/2020 calls for no further action and is disposed of accordingly.
