The applicant vide the present MA makes the following  
prayers:-

*“4. In view of the above facts, it is most respectfully prayed before this Hon'ble Tribunal that the following modification/correction may please be allowed:-*

*(a) Modify/correct Para 1(a) of the judgment dated 21.08.2025 passed in OA No. 2567/2025, to read that the notional increment was due on 01.01.2025 for the period 01.01.2024 to 31.12.2024, in place of the presently mentioned period 01.01.2016 (for 01.01.2015 to 31.12.2015).*

*(b) Pass such further orders as may be deemed just and proper in the interest of justice.”*

2. A perusal of the records of the OA 2567/2025 indicate that the prayers as put forth in prayer 8 (a) and 8 (b) in the prayer clause have inadvertently not been put correctly into the

paragraph 1 of the order dated 21.08.2025 in OA 2567/2025 is thus rectified to incorporate the prayers 8 (a) and 8 (b) therein and thus para 1 of the order dated 21.08.2025 in OA 2567/2025 is rectified to read as under:~

***"8. RELIEF(S) SOUGHT:***

*For the facts and circumstances stated above, the applicant most respectfully prays that this Hon'ble Tribunal may be pleased:*

*(a) To direct the Respondents to grant one notional increment due on 01/01/2025 (For the period of (01.01.2024 to 31.12.2024) and a fresh corrigendum PPO be issued duly re fixation of pension with all consequential benefits along with its arrears and interest thereon @18% per annum in the interest of justice.*

*(b) To pass such further order or orders, direction/Directions as this Hon'ble Tribunal may deem fit and proper in accordance with law."*

3. The MA 191/2026 is thus disposed of accordingly.
