All the 15 applicants who are applicant in OA 654/2022 had filed this application for execution of an order passed by this Tribunal in OA 654/2022.

2. In OA 654/2022, the case of 15 applicants for grant of notional increment in accordance to the law laid down by the Hon'ble Madras High Court in the case of P. Ayyamperumal Vs. The Registrar, Central Administrative Tribunal, Madras Bench and Ors. (WP No.15732/2017) decided on 15<sup>th</sup> September, 2017, was directed to be considered in accordance with law. The application was allowed on the very first day without notice to the respondents and respondents were granted liberty to decide the claim and pass

a speaking order in case the applicants were not entitled to notional increment. Out of the 15 applicants, the following 11 applicants were not entitled to grant of increment:-

- (iii) Ex MWO (HFO) Ram Kumar Singh Batar

- (vi) Ex MWO (HFO) S Baburajareegam
- (vii) Ex MWO (HFO) Guttikonda Syam Sundara Rami Reddy
- (viii) Ex MWO(HFO) Ram Vir Singh
- (ix) Ex MWO(HFO) Suresh Kumar Talwar
- (x) Ex MWO (HFO) Rampal
- (xi) Ex MWO Ram Naval Verma

and therefore in their case speaking orders were passed. In the case of other four applicants namely, (i) Ex MWO Brajesh Sharma, (ii) Ex MWO Rabindra Nath Singh, (iii) Ex WO Ramayan Pratap Singh, (iv) Ex WO Asmuni Yadaw, PPOs have been issued and the same have been brought on record.

3. In view of the compliance reported by the respondents, this application stands disposed of.

4. As far as 11 applicants in whose case speaking order has been passed liberty shall be available to them to assail the speaking order in case they are aggrieved of the same, in accordance with law.

5. MA stands disposed of.
