The applicant IC-57924M Col Sujit Pal vide the present OA filed under Section 14 of the Armed Forces Tribunal Act, 2007 makes the following prayers:

- (a) *"Call for the records based on which the respondents most discriminately have fixed the pay of the applicant in the rank of Col . w.e.f. 13.06.2024 instead of from date of next increment i.e. from 01.07.2024, as well as the records based on which the respondents issued the impugned orders thereafter quash all such orders.*
- (b) *Direct the respondents to fix the pay from the date of next increment from 01.07.2024 consequent to grant of promotion to the rank of Col on 13.06.2024 instead of*

fixation of pay and allowance from the date of promotion by quashing the order of such fixation and revise his pay accordingly by granting two increment(Promotion increment+ Annual Increment) on 01.07.2024 and annual increment on 01.01.2025 to the applicant as per Addl Dte Gen Personnel Services letter dated 23.03.2021 as granted to his batch mates and the juniors.

- (c) *Direct the respondents to pay the arrears of the difference of pay accrued upon grant of two increment from 01.07.2024 after adjusting the payments already made alongwith interest @12% from the date it was payable till the date payment is made.*
- (d) *Pass any other order/orders as deemed appropriate by this Hon'ble Tribunal in the facts and circumstances of the present case."*

2. The applicant was commissioned in the Indian Army on 13.06.1998 after having been found fit in all respects and was promoted to the rank of Major on 13.06.2006 and then to the rank of Lt Col. on 13.06.2011. The applicant submits that the Pay Rule-2017 was promulgated w.e.f. 01.01.2016 and that the Advisory No.11/2021 dated 23.03.2021 was issued by the Addl Dte Gen Personnel Services notifying all Commands that as per the 7th CPC there are two dates for increment on 1st January and 1st July of every year depending on the date of appointment or promotion or financial up-gradation if a

person promoted or financially upgraded from 1st January to 1st July and the date of increment as per previous rank/post is 1st July every year, and if the person has opted for Date of Next Increment(DNI), then two increments (annual+promotion) will be given in July same year and one increment(annual increment) will be given on 1st January next year. The implications of the said Advisory are detailed in the letter No.C/70 99/Policy/SAPCS/2021 dated 23.03.2021 to the effect:

"3. The implication of DMA letter above are explained as under:

3. The applicant submits that he was promoted to the rank of Col on 13.06.2024 but he was not aware that it will be more beneficial if he would have opted for fixation of pay upon grant of such promotion to the rank of Col from the date of next increment i.e. 01.07.2024 and accordingly vide letter dated 26.12.2024, he forwarded Option Certificate and Part II Order for fixation of pay from the date of next increment. The applicant further submits that he apprised the issue to the SAPCS, Addl Dte General Personnel Services, IHQ of MoD (Army) vide letter dated 07.02.2025 regarding fixation of less pay by the CDA(O), Pune than his course-mates who got promotion on the same day but the respondents stated that the OPTFXDNI was not received by them within three months of promotion and no action on the part of the respondents have taken so far. The applicant submits that despite approaching the concerned authorities of the respondents from time to time, all have expressed their inability to provide relief in the matter in the absence of order from the Armed Forces

Tribunal and vide *JK* impugned order dated 28.02.2025 placed on record as Annexure A-1, it was stated to the effect:

Subject: Fixation of Basic Pay in r/o Col(TS) Sujit Pal, IC 57924M, CD A/C No.01/002/189816L

Reference: Your DO letter No.A/27018/Offr/OS-28 dated 7 February, 2025 addressed to the PCDA(O), Pune by name.

Please refer to your DO Letter regarding fixation of Basic Pay as per DNI Option. The issue raised by you has been comprehensively examined and the following is furnished below.

2. *With regard to your DO letter, you have compared your Basic Pay with Col(TS) Anuj Gandhi, who was commissioned on the same date i.e. on 13/06/1998. It is found that your Basic Pay is less than the pay of your batch mate due to non exercising of DNI Option on promotion to the rank of Col(TS) wef 13/06/2024 whereas your batch mate is drawing more pay by one increment as he had exercised DNI option on the same promotion. In your case, as per available record, no option form is found received within the stipulated time period. You have published casualty OPTFXDNI from 13/06/2024 in PII order No.644 dated 26/12/2024 which is beyond the stipulated time of 3 months.*

3. *In the above context, as per Department of Military Affairs Letter No.1(4)/2021(Pay/Services) dated 04/06/2021, Officer should exercise option within three months from the date of promotion. In the present case, no option form found revived in the Office within the stipulated time which is three months from the date of promotion to the rank of Col wef 13/06/2024. This Office has no discretion to relax the above provision and accept the option exercised after the due date.*

4. *In compliance to the ibid Order, Basic Pay could not be re-fixed as per DNI option. Action in this regard can only be taken after any further order/direction is received from Govt of India/MoD to deal with such type of case.*

5. *This is issued with the approval of PCDA."*

4. *Inter alia, it has been stated on behalf of the applicant that the matter is no more res integra in view of the order dated*

21.11.2023 of this Tribunal in OA No. 163 of 2022 in the case of

Nb Sub/M Tech(B Veh) Brijesh Singh Vs Union of India & Ors.

5. A bare perusal of the impugned order dated 28.02.2025 already adverted to hereinabove indicates that the respondents have not refuted the contention of the applicant that he was entitled to the grant of next increment from 01.07.2024 after his promotion to the rank of Col. on 13.06.2024. As observed vide order dated 21.11.2023 in *Nb Sub/M.Tech(B Veh) Brijesh Singh vs Union of India & Ors.* in OA 163/2022 vide Paras 5, 6 and 7 thereof which read as under:

“5. MoD vide its Office Memorandum dated 22.03.2018 (Annexure A-7) had intimated that anyone promoted may opt to have his/her pay fixed from the date of his/her next increment. The relevant extracts are reproduced below:

3. After due consideration in this matter, the following is decided as follows:

(i) Defence Personnel, who is promoted or upgraded from one rank to another, subject to fulfilment of the eligibility conditions as prescribed in the relevant Recruitment Rules, to another post carrying duties and responsibilities of greater importance than those attaching to the post held by him/her. Such, Defence Personnel may opt to have his/her pay fixed from the Date of his/her Next Increment (either 1st July or 1st January, as the case may be) accruing in the Level of the post from which he/she is promoted, except in cases of appointment on deputation basis to an ex-cadre post or on direct recruitment basis or appointment/promotion on ad-hoc basis, as applicable in the Defence Services.

(ii) In case, consequent upon his/her promotion, the Defence Personnel opts to have his/her pay fixed from the date his/her next increment (either 1st July or 1st January, as the case may be) in the Level of the post from which Defence Personnel is promoted, then, from the date of promotion till his/her DNI, the Defence Personnel shall be placed at the next higher cell in the level to the post to which he/she promoted.

(iii) Subsequently, on DNI in the level of the post to which Defence Personnel is promoted, his/her Pay will be re-fixed and two increments (one accrued on account of annual increment and the second accrued on account of promotion) may be granted in the Level from which the Defence Personnel is promoted and he/she shall be placed, at a Cell equal to the figure so arrived, in the Level of the post to which he/she is promoted; and if no such Cell is available in the Level to which he/she is promoted, he/she shall be placed at the next higher Cell in that Level.

6. The above details were further clarified and promulgated to the subordinate formations vide Army HQ letter dated 23.03.2021 – “Ex of DNI Option on Promotion” (Annexure A-6). Relevant options are extracted below:

2. As per 7th CPC, there are two dates for increment on 01 Jan and 01 Jul of every year, depending on the date of his appointment or promotion or financial up gradation.

3. The implication of DMA letter above are explained as under:-

(a) When Date of Increment due on 01 Jul Every Year**:

7. It is evident from the details in the letter dated 24.09.2018 (Annexure A-1) that the applicant's date of last increment in the 6th CPC was on 01.07.2015. Thus, as per Para 3 (a and b) of Army HQ letter dated 23.03.2021 (Annexure A-6), since the applicant was promoted on 01.05.2016 and that is between 02nd Jan and 30th Jun and as opted for fixing his pay from the next increments, he is entitled for two increments; one for his promotion and one his annual increment, Jul 2016 and his next annual increment would be due on 01.01.2018.",-

as the applicant was promoted on 11.06.2022 and opted for fixation of his pay from the next of increment, then he is entitled for two increments i.e. the annual increment and the second accrued on grant of promotion on 11.06.2022 with his next annual increment being due on 01.01.2023.

6. The applicant further submits that the denial by the respondents of the revised pay scale to the applicant has created a situation wherein the applicant is being granted basic pay lesser than his batch mates as well as his juniors on the specious plea of putting the onus on the applicant for not exercising the option within the stipulated time of three months from the date of publication of the Part II Order published on 22.08.2024, despite the obligation on their part to fix the pay of the applicant in a manner which is more beneficial to him are highly illegal, arbitrary and discriminatory as well as against the mandate of equality and equal pay for equal work and also contrary to the order dated 21.11.2023 of this Tribunal in OA 163 of 2022 titled *Nb Sub/M.Tech(B Veh) Brijesh Singh vs Union of India & Ors.*

7. The applicant reiterates that the actions of the respondents of denying him, the benefit of fixation of pay in the 7th CPC from

the date of next increment (DNI) on grant of promotion/financial up-gradation i.e. on 13.06.2024(two increment(Annual Increment and Promotion Increment) and instead granting only promotion increment on 13.06.2024 has resulted in a situation of the applicant getting less pay than his junior on the sole basis of applicant having not exercised the option within the stipulated period of time.

8. We have examined numerous cases pertaining to the incorrect pay fixation in 6th CPC in respect of Officers/JCOs/ ORs merely on the grounds of option not being exercised in the stipulated time or applicants not exercising the option at all, and have issued orders that in all these cases the petitioners' pay is to be re-fixed with the most beneficial option as stipulated in Para 12 of the SAI 2/S/2008 dated 11.10.2008. The matter of incorrect pay-fixation and the most beneficial option in the case of JCOs/ ORs has been exhaustively examined in the case of Sub M.L. Shrivastava and Ors Vs. Union of India [O.A No.1182 of 2018] decided on 03.09.2021.

9. In the light of the above considerations, the OA 2766/2025 is thus disposed of with directions to respondents to the effect:

- a) To fix the pay of the applicant from the date of his next increment from 01.07.2024 consequent to the grant of promotion to the rank of Col. on 13.06.2024 in the 7th CPC.
- b) On re-fixing his pay in the 7th CPC on 01.07.2024 the applicant be granted two increments' one for promotion and the other for annual increment.
- c) His subsequent pay be recalculated accordingly.
