
Sir,

- (b) Please inform whether the Selection Committee has recommended the names for appointments of Judicial and Administrative Members of the AFT, alongwith the total number of all such names recommended and the current status of pendency of the file related to their appointments.
- (c) Please inform whether the AG's Branch/DV Directorate or any other branch of the Army HQ or any other Military establishment has attached or made available serving Army personnel with Administrative Members of the AFT at any Bench for purposes of use at the AFT or at their residence or for any other use, and if yes, then please provide a copy of the authority letter or the govt rule under which such military personnel can be made available for use of Administrative Members of the AFT or the AFT. Please also provide details and copies of the requests received from any such Administrative Member or the AFT for making available to them the services of military personnel.
- (d) Please inform whether any Military Command or any military unit or establishment has provided manpower/buddies/sahayaks etc or any other facility to any Administrative or other Member of the AFT, and if yes, then please provide a copy of the authority under which the same has been done.
