- 1. Heard Ms. Tonifia Miranda, Learned Counsel for the applicant, on admission.

While submitting arguments regarding admission, the Learned Counsel would state that she may be permitted to withdraw the application with liberty to exhaust the remedies of the applicant before the Ministry of Defence and suitable directions may be issued for filing the fresh Original Application on the same cause of action and on the appeal likely to be preferred by the applicant before this Tribunal. She also wishes to make endorsement in the Original Application. Accordingly we permit the Learned Counsel for the applicant to make endorsement to that effect.
- 3. 4. With the aforesaid observations, the application is dismissed as withdrawn with the aforesaid liberty to the applicant.
