Heard Mr. V.K. Sathyanathan, counsel for the applicant. Admit.
Issue notice. Mr. S.Krishnamoorthy, Senior Panel Counsel, accepts notice on
behalf of the respondents. He prays for and is granted two weeks time to

file a reply statement.

Mr. Sathyanathan, counsel for the applicant submitted that the applicant was enrolled in the year 1992 as a Store Keeper Technical (Skt) in the Madras Engineering Group (MEG) and later on was voluntarily transferred to MES Militarised Cadre (SK). He became Havildar in the year 2009, whereas according to the applicant, his contemporaries who remained in the MEG became Havildars eight years before the applicant as there was a separate seniority roster. The merger directed by Annexure A6 will, it is submitted, affect the seniority of the applicant. Counsel for the applicant also brought to our notice the order of the Calcutta Bench of the Tribunal in OA. Nos.74 of 2011 and 75 of 2011 and connected matters in which interim order has been granted. The learned counsel for the applicant also placed before us an interim order in a similar matter granted by the Principal Bench of the Tribunal in OA NO.191 of 2011 and connected matters, in which an order of status quo was passed. In such circumstances, until the next date, viz. 8.2.2012, the status quo will be maintained in respect of the applicant.
