3. The applicant Premanathan.K. JC 307950 W filed W.P.No.2576 of 2008 in the Karnataka High Court for the discharge order No.1363/CA/Statsquashing 1/DO/LMC/MAR 2008/J/07 dated 3rd October, 2007 (Annexure A1).
