Master (CPO) Indrabhan Singh in person and Mr. A.J. Mishra, Ld. Counsel for the respondents.</p> <p>Applicant states that respondents have neither correctly fixed his basic pay nor paid the interest on arrears correctly. As per order, interest is payable on both arrears of pension and commutated value of pension. He has filed a calculation chart as directed by the Tribunal, and respondents were obligated to check the same and ^{in case of difference} submit their own calculation chart, but they have not done so.</p> <p>Learned counsel for the respondents submits that respondents have submitted their reply after getting the calculation chart submitted by the applicant checked by the PCDA, Mumbai.
